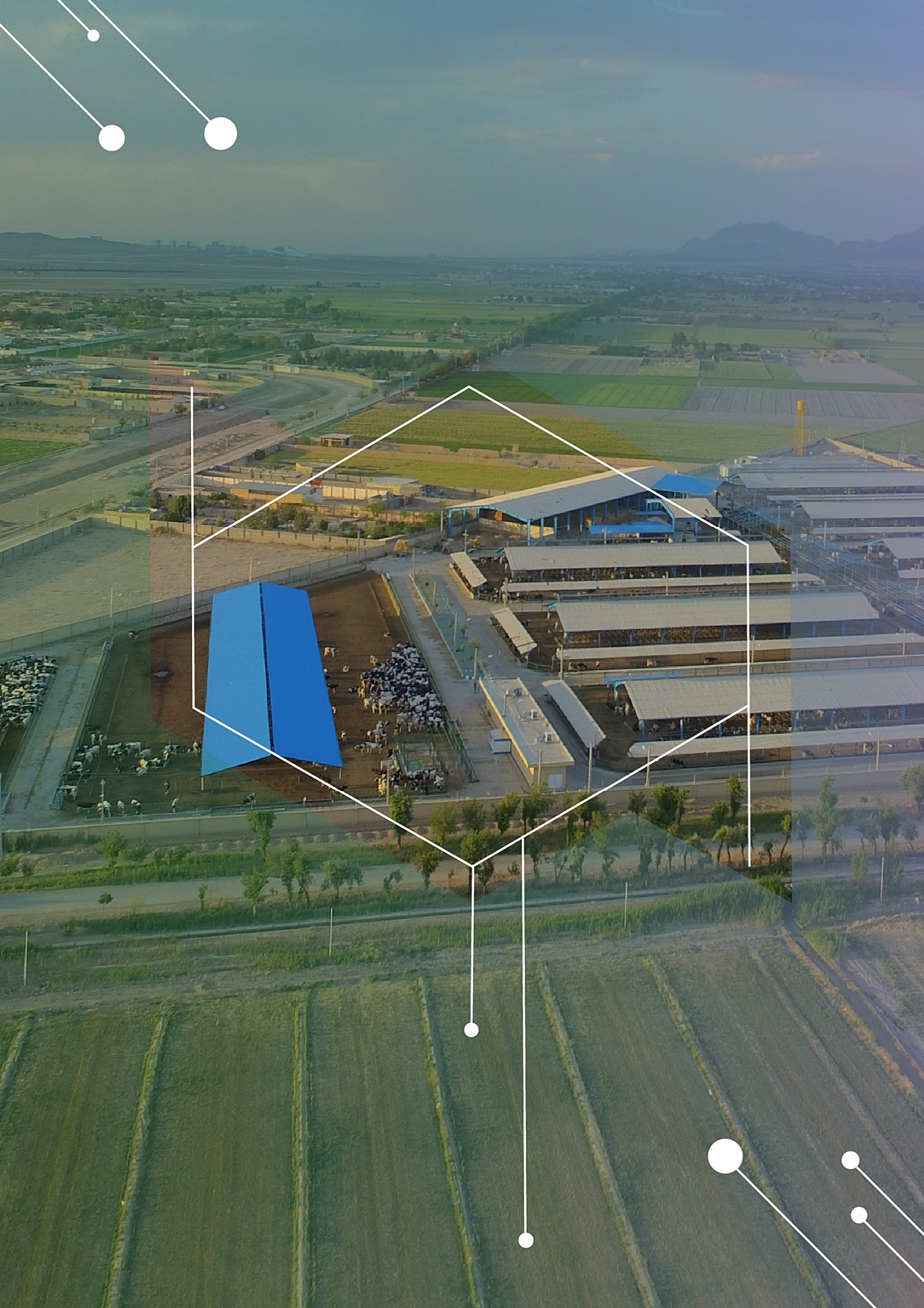

Introduction

Tamin Agriculture & Husbandry & Dairy Investment Company (TAHDICO) (Public Joint Stock) was established on Feb. 2004 ,16 and is currently one of the holdings of the Social Security Investment Company (Shasta) which has invested in the chain of agriculture, animal husbandry and dairy industries.

With 33,000 cows and an annual production of 220,000 tons of milk, this holding is the second-best producer of raw milk in Iran. In this company, the per capita milk production record in all the units of the holding is above 40 kg, and the quality of the production process has favorable conditions, and some units have succeeded in obtaining excellent health and safety certificates (IR standard).

Based on the developed vision and mid-term planning, several creation and development projects in the field of agriculture, animal husbandry and dairy products have been defined and started in this holding, and with the establishment of advanced production units in apt but deprived areas, the raw milk production capacity of the subcompanies of this holding will reach 500 thousand tons in 1405 [March 2026 ,21 to March 2027 ,20].



Perspective:

Becoming one of the largest investment companies in the country in the field of animal husbandry industry by completing the value chain in the mentioned industries and reaching the production of 500 thousand tons of milk in a five-year period.

FKA Agriculture and Animal Husbandry Company

FKA company started its activity in 1974 in the south-east of Isfahan in the field of agriculture and animal husbandry.

Due to the existence of technical knowledge and the use of laboratories equipped for the production of fetus, nutrition and raw milk, this company has succeeded in obtaining a knowledge-based animal husbandry license from the Presidential Science and Technology Department and has provided the field of activity for 300 people directly and about 700 people indirectly.

One of the capabilities of this company is the daily production of more than 250 tons of raw milk from Holstein breeds with an average of 45 kg and Jersey with an average of 25 kg. Among the strengths of this company is the annual supply of more than 1500 pregnant heifers, 800 tons of red meat, more than 3000 male Holstein calves and different breeds. Furthermore, this company produces and sells a large number of laboratory fetuses with excellent genetic characteristics and produces high quality milk from Jersey cows, in three husbandry units with a capacity of 15,000 head using a feed factory with a capacity of 15 tons per hour.

The noteworthy point in the outstanding record of FKA Agriculture and Animal Husbandry Company is the export of pregnant heifers, fetuses and technical knowledge of establishing and launching industrial animal husbandry to different countries.

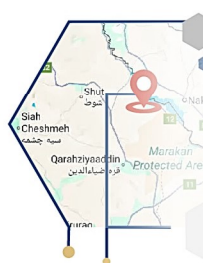


Aras Dam Arsham Company

This company is one of the industrial husbandry farms in Iran, which was registered in the Maku Commercial-Industrial Free Zone in 2018, and with an investment of 250 billion tomans (2,500,000,000,000 IRR), it has been put into operation in the first phase, and the second phase is being followed up and implemented. This company has employed 100 people directly and 350 people indirectly in a deprived area.

The number of 1500 productive animals, 1300 dairy animals with daily production of more than 50 tons and annual production of about 20 thousand tons of milk and 200 tons of red meat are among the activities of this animal husbandry unit. The use of up-to-date technology in the animal husbandry industry, high-quality genetic breed and the use of 1000 hectares of mechanized and fertile agricultural land are the strong points of this company, which distinguish it from other companies.

The strategic position of the mentioned company and its establishment in Maku Free Zone has attracted the attention of the managers, in addition to the market of the northern and western provinces of Iran, to export products to neighboring countries such as Azerbaijan, Armenia and Turkey.

Goldasht Nemooneh Isfahan Company

This company, with an area of about 45 hectares, built with the latest designs and maps, has the capacity to keep 8000 livestock. The daily production in the main unit of the company is 150 tons of raw milk with an average production of 44 kg per head, and 4200 male and female calves are born in this company every year. This volume of production has directly caused the employment of 190 efficient personnel and has indirectly provided employment for about 500 people.

Production of more than 55 thousand tons of raw milk per year, production and supply of pregnant heifers with high genetic purity is one of the capabilities of this company. Providing technical engineering services in the creation and setting up of advanced industrial cattle farms in the domestic market as well as exporting to other countries, the annual production and supply of about 2200 male calves to breeding units is another capability of this company. Goldasht Nemooneh Company has the potential ability to acquire the market and improve the quality of Iran's industry by having two livestock breeding projects in Delfan, Dargazin and also the project under construction in Shirvan.

Dargazin Animal Husbandry Complex

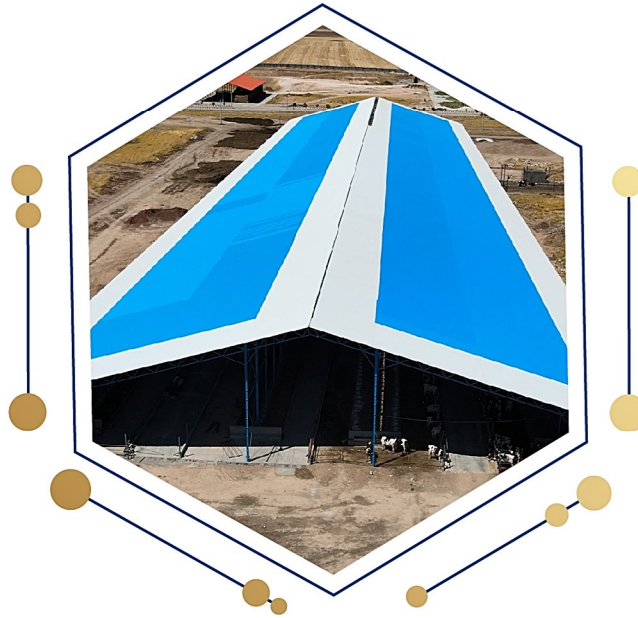
This complex, located in Dargazin County, Hamedan Province, is one of the development projects of Goldasht Nemooneh Isfahan Agriculture and Husbandry Company, in a deprived and underdeveloped area of 60 hectares, in 1401 [March 2022 ,21 to March 2023 ,20], with a capacity of 3000 breeding heads and a number of 150 personnel, it started its activity with the transfer of 500 pregnant heifers.

Currently, about 1350 productive animals are bred there. This unit produces about 50 tons of milk daily, about 17 thousand tons of milk and about 100 tons of red meat annually. The average daily milk production of the unit is currently 41 kilograms per head.

Currently, 75 people have been employed in this unit, which has the potential to create much higher employment by completing the capacity or increasing the capacity.

The annual supply of animal feed required by the complex includes livestock inputs, fodder corn, hay press machine, straw press machine, and is generally purchased from the farmers of the region, so that while the economic cycle of the agricultural industry is booming, it also plays a role as a support and driving force of agriculture in the neighboring provinces.

Delfan Animal Husbandry Complex

Delfan Animal Husbandry Complex located in Delfan County, Lorestan Province, is one of the development projects of Goldasht Nemooneh Isfahan Agriculture and Husbandry Company with an area of 54 hectares, which started its activity in 1401 [March 2022 ,21 to March 2023 ,20] with a capacity of 3000 heads by transferring 500 pregnant heifers.

At present, the number of about 1350 productive livestock is raised in it. This unit produces about 50 tons of milk daily, about 17 thousand tons of milk and about 100 tons of red meat annually.

With the planning of training, job creation, creation and development of infrastructure, 75 young and capable workers have been directly recruited in this deprived area, which will reach 150 people in the future.

The Shirvan Project

This project with an investment value of 779 billion tomans (7,790,000,000,000 IRR) is being built in an area of 50 hectares in Shirvan area of North Khorasan province with a capacity of 3000 productive livestock and an annual production of 36 thousand tons of milk. With the implementation of this project in this deprived and underdeveloped area, employment of 130 people will be possible.

According to the approved explanatory plan, if the first phase is completed with the transfer of 1350 productive livestock, 50 tons of milk will be added to the milk production capacity of Iran, which will reach 100 tons per day by the end of the second phase. It should be noted that the first phase of this project will be put into operation in the second quarter of 1404 [March 2025 ,21 to March 2026 ,20].



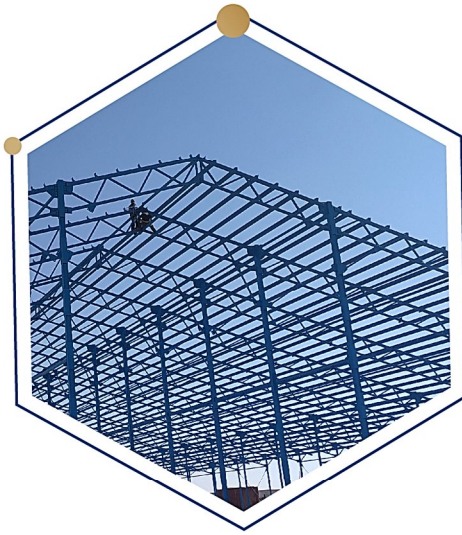


Malard Shir Company

Malard Shir Agriculture and Husbandry Company is more than half a century old, and it is built on a land of about 200 hectares (160 hectares of barley, corn, alfalfa area and 40 hectares of cattle area).

This company has the capacity to maintain 6000 livestock and produce 2500 male and female calves annually, equipped with an advanced feed factory of 15 tons per hour, as well as 32- and 80-unit milking machines. Malard Shir Company has one of the best herds of pure Holstein cows with a daily production of 120 tons of raw milk and a production efficiency of 41 kilograms per day, which is expected to play a more prominent role in the milk production of Iran by exploiting the project under construction. Raw milk, meat, heifer and fertilizer are among the products produced by this company. Being located near the capital and transit transportation routes of Iran, as well as 160 hectares of agricultural land adjacent to the farm, are among the advantages of Malard Shir Company.





The Malayer Project

This project is being built in an area of 60 hectares and with an initial investment of 803 billion tomans (8,030,000,000,000 IRR) in Malayer County, Lorestan Province with a capacity of 3000 head of productive livestock and an annual production of 3600 tons of milk. And based on the planning, it has the ability to develop up to 6000 heads. With the implementation of this project in this deprived and underdeveloped area, 130 people will be directly employed.

According to the explanatory plan of the mentioned project, if the first phase is completed with the transfer of 1350 productive livestock, 50 tons of milk will be produced daily, and by the end of the second phase, the daily production will reach 100 tons. The first phase of this project will be put into operation in the second quarter of 1404 [March 2025 ,21 to March 2026 ,20].



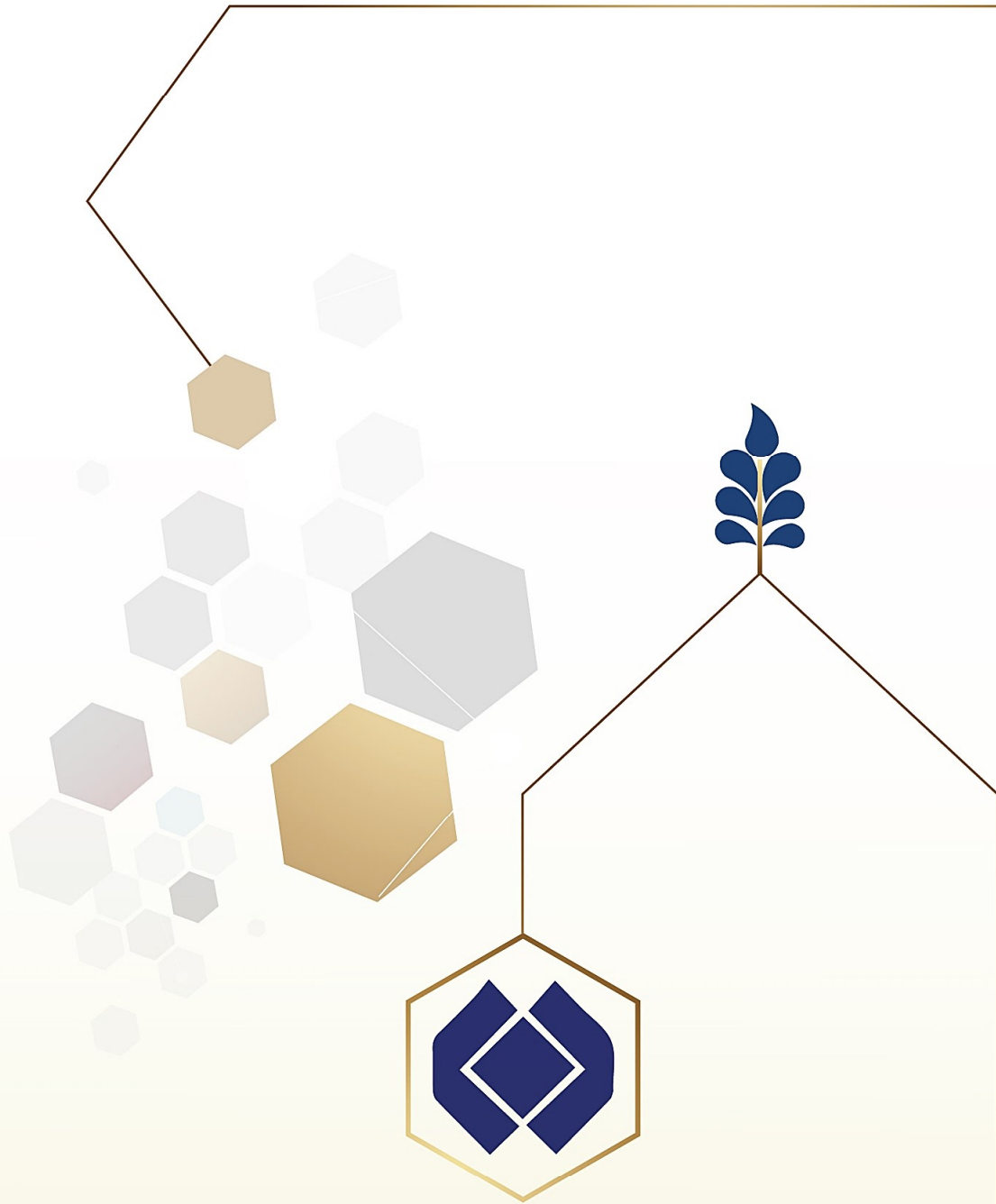


The company with a new, equipped and advanced production line is one of the best quality companies in Iran's food industry, which was put into operation in the solar year of 1400 [March 2021 ,21 to March 2022 ,20] for the production of various types of dry milk, cheese powder and industrial cream and by creating employment for 70 people in the first phase. Proteins obtained from milk and cheese juice, lactose, caseinate, butter, animal oil, primary cheese and pizza cheese are the products of this company in the second phase development plan. This company has succeeded in producing grade A+ (basic) milk powder for the purpose of producing baby milk powder by using the world's modern knowledge and its educated and capable employees.

Currently, the company has the capacity to absorb 200 tons of raw milk and also produces 16 tons of non-fat dry milk and 15 tons of 40% cream per day, which is indirectly heated, which is the distinguishing factor of the products of this factory and the factor of increasing its quality.


Despite the short launch period, the export of Damon Zagros Company's high-quality products under the Zagshir brand has been carried out to various countries including Qatar, UAE, Pakistan, Iraq, Afghanistan and Syria.
